Required eLearnings – All Students

All students completing an educational rotation at a TriHealth facility are required to complete the following online requirements prior to the student experience. Students must print certificates of completion as indicated and provide copy to Security and the school representative and should be maintained by the school.

Badging and Security:

All students will receive a badge for each student assignment; background form and fingerprinting will be done in Security. Contact Security to schedule a time to obtain your badge (unless this has been arranged by the instructor or TriHealth coordinator for you). Students who report to security for badging and have not scheduled a time prior to arriving may be instructed to return at a later time to obtain a badge.

When reporting to Security, the following must be presented to Security and is REQUIRED to obtain the badge:

- Government issued photo ID
- Vehicle Registration
- Know your social security number, card is not necessary
- Annual Mandatory Education certificate of completion for current calendar year Badges must be returned to Security on the last day of the clinical rotation.
